

Archery Range at Wilson Hall use Guidelines and Rules

All users must refer to, and adhere to, the map of the parking areas, range limits and use requirements. Failure to follow all rules will be grounds for suspension of privileges and potential citation by DES, Law Enforcement.

Archery Range is open generally from sunrise to sunset daily. Specifically, the range will be available for use only when available in iSportsman for selection and check-in and out on the day of use.

All users must acknowledge these guidelines and the associated map and then acquire the Archery Range Permit in their iSportsman Account.

Prior to entering and using the range, all users must check into the range thru their account. No later than sunset on that day all users must be checked out of the range and exit the facility. Failure to check out will be grounds for suspension of privileges.

There will be no access FOR ANY REASON beyond the Hazard Impact area signs along the down range side of the range. Arrows that go beyond the signs are LOST. Users MUST adhere to this rule, if you do not understand ask. Persons reported to be or are found beyond the signs will be cited and suspended from ALL recreational activities. Access to the range will be through the breezeway between C and D Wings of Building 9297. If a person is mobility impaired please coordinate with the Hunt Control Staff.

All users must adhere to the rule of "if you carry it in, carry it out". Leave NOTHING when you depart. Failure to follow this rule will result in closing of the facility permanently.

Archers are required to **place their names on** and provide their own target and should take everything out with them when you leave, including the target(s) regardless of condition. Targets must be of sufficient quality and makeup to stop arrows.

Bows that have been charged with an arrow will remain pointed down range between the orange range markers until released. Direction of shooting will be perpendicular to designated firing line, no cross- range shooting.

All archers must have a foot in contact with the shooting line while in the act of shooting. All spectators must remain behind the shooting line at all times while range is active and must stay directly with shooter to retrieve arrows or stay behind firing line.

Any user under the age of 18 must be accompanied by an adult that must be in immediate proximity to the youth at all times while on the range, NO EXCEPTIONS.

Alcohol or other intoxicants will not be consumed prior to or during use of the facility. Anyone found in violation will be suspended and potentially cited per Ft Knox Regulation regarding intoxicants.

No personnel beyond the designated shooting line unless all participants acknowledge and all bows are unloaded. NO working on equipment beyond the shooting line.

Eye protection is recommended, closed-toed shoes are required while on the range.

All users must park in the locations identified on the map, no exceptions. Violators will be barred from future use of the range.

I accept these guidelines and have referred to the referenced map and commit to adhere to the stated rules and guidelines. If I witness violations of the above, or other unsafe acts, I will report these to the Hunt Control Office (502 624-7311) and/or DES Game Wardens (502 624-2111)
